4	We are on the record in the matter of the State of Michigan as to Thomas
5	Miller. File 151067FY. Counsel, please state your appearances for the record.
6	Mr. Doe: Good afternoon, Your Honor. John Doe appearing on
7	behalf of the People.
8 9	Mr. Blanchard: Good afternoon, Your Honor. Josh Blanchard on behalf of Mr. Miller.
10 11	The court: And the record should also reflect that Mr. Miller is also present.
12	Good afternoon, sir.
13	Mr. Miller: Hello.
14	The Court: This is the date and time scheduled for preliminary
15	examination on three counts.
16	Count one alleging that on or about July the 9 <sup>th</sup> of 2015 in the City of
17	Marquette, County of Marquette, and State of Michigan that you did engage in sexual
18	penetration, that being penile vaginal with Melissa Jones under circumstances
19	involving the commission of another felony an assault by strangulation.
20	That is a felony offense punishable by life or any term of years,
21	Mandatory electronic monitoring, mandatory AIDS and STD testing, and DNA would
22	be taken upon arrest. It is also a Tier Three offense under the Sex Offender Registration
23	Act.
24	Do you understand the charge?
25	Mr. Miller: Yes.

1	The Court: In Count Two the Complaint alleges that on or about July the
2	9 <sup>th</sup> of 2015, in the City of Marquette, County of Marquette, and State of Michigan you
3	Did engage in sexual penetration, that being penile vaginal with Melissa Jones, the
4	Defendant and victim being related by blood or affinity to the third degree.
5	That is a felony offense, It is punishable by 15 years in prison,
6	Mandatory AIDS/STD testing and, again, DNA would be taken upon arrest. This
7	Too is a Tier Three offense under the Sex Offender Registration Act.
8	Do you understand the charge?
9	Mr. Miller: Yes.
10	The Court: Do you also understand the potential penalty for the
11	charge?
12	Mr. Miller: Yes.
13	The Court: And, finally, in Count Three, the Complaint alleges that on or
14	about
15	July 9 <sup>th</sup> of 2015, in the City of Marquette, County of Marquette, and State of Michigan,
16	you did engage in sexual penile vaginal with Melissa Jones and that you and she
17	were related by blood or affinity to the third degree.
18	Again, a felony offense, punishable by 15 years in prison, mandatory
19	AIDS and STD testing, and DNA would be taken upon arrest. It is also a Tier Three
20	Offense under the Sex Offender Registration Act.
21	Mr. Miller, do you understand that charge?
22	Mr. Miller: Yes.
23	The Court: Do you also understand the potential penalty for the
24	charge?
25	Mr. Miller: Yes.

1	THE COURT: And, Mr. Doe, are the People prepared to proceed?
2	MR. DOE: We are, Your Honor.
3	THE COURT: Okay.
4	And, Mr. Blanchard, on behalf of Mr. Miller?
5	MR. BLANCHARD: Yes, Your Honor.
6	THE COURT: Okay
7	Are there any preliminary matters?
8	MR. DOE: Not for the People.
9	MR. BLANCHARD: Not from the defense.
10	THE COURT: Okay.
11	And, Mr. Doe, any opening statement?
12	MR. DOE: No, Your Honor, unless defense objects.
13	MR. BLANCHARD: Nope.
14	THE COURT: Okay, then we'll go forward. You may call your first witness.
15	MR. DOE: Thank you, Your Honor. The People call Melissa Jones.
16	THE COURT: Good afternoon, Ms. Jones. Will you raise your right hand for me?
17	Do you solemnly swear or affirm that the testimony you're about to give will be
18	The truth and nothing but the truth?
19	MS. JONES: Yes, ma'am.
20	THE COURT: Go ahead and be seated.
21	Please state your full name and spell both your first and last name for the record.
22	THIS WITNESS: Melissa Ann Jones. M-E-L-I-S-S-A. J-O-N-E-S.
23	THE COURT: Thank you.
24	Go ahead, Mr. Doe.
25	MR. DOE: Thank you.

1		MELISSA ANN JONES
2		(At 2:08 p.m., sworn as a witness, testified as follows)
3		DIRECT EXAMINATION
4	BY N	MR. DOE:
5	Q	Ms. Jones, are you familiar with some named Thomas Miller?
6	A	Yes.
7	Q	How do you know Thomas Miller?
8	A	He's my maternal uncle.
9	Q	you have your mother—or you have a grandmother in town, is that correct? Your mother
10		and his mother were half-siblings?
11	A	His—My mother is his sister.
12	Q	Okay, how long have you known Mr. Miller?
13	A	My entire life.
14	Q	What kind of relationship have you had with Mr. Miller your entire life?
15	A	Pretty much normal relationship uncle, nice. He changed my diapers when I was little.
16	Q	Would you recognize him if you saw him?
17	A	Yes.
18	Q	Can you describe what he is wearing?
19	A	An orange jumpsuit with orange slippers.
20		MR. DOE: May the record reflect identification of the Defendant?
21		THE COURT: Any objections, Mr. Blanchard?
22		MR. BLANCHARD: Not for the purposes of preliminary examination, only.
23		THE COURT: Okay.
24		The record will reflect the identification of Mr. Miller.
25	BY MR. DOE:	

Did you see Mr. Miller on July 9th of this year? Q 1 A Yes, ma'am. 2 Q Where did you see him? 3 At his residence. 4 A Q And that's in .....? 5 Yes, ma'am. 6 A Did you go to his residence? 7 Q Yes, ma'am. 8 A 9 Q Why were you there? 10 A I was helping my grandmother complete restoration on the home. Q Was Mr. Miller present the entire time you were there? 11 No, ma'am. 12 A So, you were there and then, at some point, he came to the residence? 13 Q A Yes. 14 And, at some point, you tow ended up in—at a direct location? 15 Q 16 Α Yes. How did that happen? 17 Q At first, he asked if I wanted to come back later and have some drinks and barbeque. And 18 A 19 I said, yeah. I had had a really bad day. I just wanted to relax so I had said yeah. And before all that happened he came back down and said, hey, would you like to go to the 20 hot tubs. 21 22 Again, I wanted to relax, so I was like, absolutely, sure. So, he made the reservations at – I believe it's the Hot Tub House, and he drove over there. I rode with him over there to 23 the hot 24

tubs.

- 1 Q Do you know where that's located?
- 2 A Huron Street or something.
- 3 Q Do you know what city of county it's located in?
- 4 A I know it's in Marquette.
- 5 Q Okay. Whose car did you go in?
- 6 A His.
- 7 Q Did you stop anywhere on your way to the hot tub place?
- 8 A We got lost, but then right before we went to turn onto the proper street we stopped
- 9 a liquor store that's kind of caddy cornered from-
- 10 Q Do you know the name of the liquor store?
- 11 A It was a green building.
- 12 Q Okay
- 13 A I have no idea
- 14 Q Did you go into the liquor store?
- 15 A No, ma'am.
- 16 Q Did he go into the liquor store?
- 17 A Yes.
- 18 Q Before he went—before you went to the liquor store, had you been drinking?
- 19 A Yes.
- 20 Q Would you say you were drunk at this point?
- 21 A I was somewhat inebriated, yes.
- 22 Q After the liquor store, where did you go?
- 23 A Right to the hot tubs.
- 24 Q Whose name was the reservation on?
- 25 A It was under my maiden name.

- 1 Q All right. Did you make the reservation?
- 2 A No.
- 3 Q Who paid for the hot tub?
- 4 A I paid for it with my debit card, and then he gave me \$20.00 cash, because he said he
- 5 didn't have enough cash to pay for it, because he had bought the drinks at the liquor
- 6 store.
- 7 Q The reservation under your maiden name, what was your maiden name?
- 8 A Williams. W-I-L-L-I-A-M-S.
- 9 Q What happened next?
- 10 A They made us sign a piece of paper with all the rules and whatever. We were late to our
- appointment, so they switched our appointment time. And then we went back into the hot
- tub. I believe it was room number eight. I can't really remember, but I think it was eight.
- It was all the way at the very end of the hallway to the right after you walk in.
- 14 Q What time was your appointment originally scheduled for?
- 15 A I believe it was seven o' clock.
- 16 Q And what time was it when you got there?
- 17 A About quarter after.
- So you were in a room at the end of the hall. I'm assuming in the room is a hot tub, is that
- correct? There's a hot tub in the room?
- 20 A No, it's outside.
- 21 Q Okay.
- 22 A It's like a room and the room has a bathroom, a shower, and a change like part –
- 23 Q Okay.
- 24 A -an open changing room, and then the hot tub was actually outside of the facility.
- 25 Q All right. Di you change at all?

- No, I was already wearing my bathing suit. I went home and gotten ready and changed 1 Α 2 into my bathing suit at home. So, did you get right into the hot tub? 3 Q Yeah, I did. 4 Α O Did Mr. Miller get into the hot tub? 5 He took his clothes off down to his underwear and then got into the hot tub. 6 A 7 Were you two continuing to drink at this point? Q He had bought like min—I guess they're called shooters or something. They're like little 8 Α 9 bottles of alcohol. There was four of those bottles. Two for each of us. 10 Q You said that you had been drinking. Had he been drinking? A I don't know. 11 Okay. So what happened when you were in the hot tub? 12 0 At first we just got in the hot tub and we were talking. Just normal conversation. Nothing, 13 Α you know, out of the ordinary. We then had the first set of shots, which I believe were 14 called Kinky Pinkies. 15 16 Q Mmm-hmm. I don't know what kind of alcohol it is, but they were pink—some kind of pink alcohol. 17 A And then we were talking—I'm pretty open about my sexuality. We were talking about 18 19 like a porn site that we both visited. MR. BLANCHARD: I'm going to object to narrative form, Your Honor. I mean, I 20 think we ought to have a question and answer here. 21 22 BY MR. DOE:
- After you were talking-23 Q
- THE COURT: Hang on a second, do you have any response to that? 24
- 25 MR. DOE: I can ask more questions.

- 1 THE COURT: I'll sustain the objection for now then.
- 2 BY MR. DOE:
- 3 Q So, you're talking about the porn site.
- 4 A Uh-huh.
- 5 Q What happened next?
- 6 A I was talking about another porn site that I had registered on when I was like 22 or 23.
- 7 It was like right after I got married—or after I got divorced from my marriage. And I
- was talking about the picture that I have on there, but it's of my chest.
- 9 Q So, this is a site where you had posted a picture of yourself?
- 10 A Yeah, it's an adult site.
- 11 Q Okay.
- 12 A I was recently divorced so, you know.
- 13 Q And that would have been how long ago?
- 14 A 2007, I believe.
- Okay. So, when you told him about that picture, what happened next?
- 16 A He said he was curious to see what they looked like, and then—my top was pretty much;
- iust floating up, so I just finished, and he said, yeah, they're pretty perfect. He swam
- across and touched them.
- 19 Q When you say them-
- 20 A My chest. My breasts.
- 21 Q Okay.
- 22 A I put my top back down and grabbed the other shot to try to, you know, stop that part of
- it. Got the other shot and gave him his, and then he went back to the other side of the hot
- tub where here was originally sitting.
- 25 Q So, at this point, are you tow on opposite sides of the hot tub?

- 1 A Yes.
- 2 Q Are you facing each other?
- 3 A I guess we're not really total opposites. I was facing a wall and he was like facing my
- side. It was on a different side, like far enough away, because I was up by the stairs-
- 5 Q Okay.
- 6 A -but we were on different sides of the hot tub.
- 7 Q Okay. About how far apart were you in feet.
- 8 A I have no idea. Approximately five or six feet. I don't know. I don't know big of a hot tub
- 9 it is.
- 10 Q And, at this point, you have your bathing suit on?
- 11 A Yes, ma'am.
- 12 Q And what is he wearing?
- 13 A He had on blue underwear.
- 14 Q Did those stay on?
- 15 A Nope.
- 16 Q What happened?
- 17 A He took those off. He said, that doesn't bother you does it? I said, no, not really, you're
- staying under the water, you know, so I couldn't really see anything. I wasn't bothered
- 19 by it.
- 20 Q At what point did he take those off? Was it before or after you did that second round
- 21 shots?
- 22 A I want to say before.
- 23 Q So, you grabbed those shots to try and change the subject. What happened next?
- A Actually—I know—it's so bits and pieces of everything. I was pretty inebriated at
- 25 that point. I know at one point he stood up and showed me his penis.

- 1 Q Did he say anything when he did that?
- 2 A Yeah.
- 3 Q What did he-
- 4 A He said I'd never see another one like his, because it's like three-quarters of a
- 5 circumcision. It's not a full circumcised penis, so he has a flap of skin on the bottom
- of it that's still there.
- 7 Q Did you look?
- 8 A Yes.
- 9 Q Was there something like that there?
- 10 A Yep, there sure was.
- 11 Q After he showed you that, what happened next?
- 12 A He sat back down. Again, we just went back to our regular conversation about things that,
- you know, normal things. Things we seen on the internet or, you know, stuff like that.
- It wasn't anything sexual at that point.
- 15 Q Did it become sexual at some point?
- 16 A Yeah.
- 17 Q Do you remember how that started?
- 18 A I remember somehow my top came back off.
- 19 O Do you not know how that happened?
- 20 A I don't—I don't really recall.
- 21 Q Okay.
- 22 A I'm sure—I mean, it's—I don't really recall right now.
- 23 Q Okay.
- 24 A Sorry.
- 25 Q So, your top is off again. What happened next.

- 1 A He made an advance at me. Well, actually, we were talking about the jets in the tub—in
- 2 the tub—in the hot tub, and he was trying to tell me how each—how each seat had a
- different part that it would help massage or whatever. So, I was actually rotating around.
- When I got to the spot where he was originally sitting—of course, he was moving
- as I was moving. When I got to the spot where he was originally sitting to begin with, he
- 6 swam across and he put his penis against me. At that point it was erect.
- 7 Q What did you do?
- 8 A I didn't do anything. I didn't do anything or say anything. I didn't stop it.
- 9 Q Why didn't you say anything?
- 10 A I didn't know how I was going to get home. I was stuck in a weird place. I didn't
- even know where I was at. I just knew I was in Marquette. So, I was scared I was going
- to be stuck there.
- 13 Q Did he kiss you at all?
- 14 A He tried but I kept turning my head away.
- When you would turn your head away what would he do?
- 16 A Nothing. He would still try to kiss me.
- 17 Q What happened next?
- 18 A He—He put his penis inside of me.
- 19 Q Inside of you where?
- 20 A In my vagina.
- 21 Q What way were you—what way were each of you facing? Were you facing each other?
- Was one of you facing away?
- 23 A No, we were facing each other. I couldn't—I really didn't having anything to hold on to.
- He pulled me towards him. It could be because he was closer to the middle of the hot tub.
- So, I really wasn't even on like a seat or anything.

- 1 Q What did you do?
- 2 A I just sat there and took it.
- 3 Q Did he do anything else?
- 4 A He put his hands around my throat, and squeezed and said, why won't you—it was, yeah,
- 5 it was something like that. Why won't you come or how long before you're going to
- 6 come. It was something about coming.
- 7 Q Did you say anything to him?
- 8 A No.
- 9 Q Could you breathe at that point with his hands around your throat?
- 10 A No. very little.
- 11 Q Did you feel like you were going to pass out?
- 12 A No. He didn't leave it around my throat very long, because I tried to turn to get, you
- know, to try to get away. At the point when I turned he grabbed me and started-he
- again inserted his penis into my vagina and started to go at me from behind.
- So, when you started to turn, you kind of got away from him? You did not? You're
- shaking your head?
- 17 A No, I was—no, I was basically in a corner. I was up against the side of a the hot tub-
- 18 Q Okay.
- 19 A -part, so I couldn't really go anywhere. He was in the middle of the hot tub, and we were
- on the far side, so there was no steps or anything for me to get to, to try to get away.
- 21 Q Okay, So, you couldn't get away, but you just turned?
- 22 A Yeah.
- 23 Q And while you were turning was he still inside you?
- 24 A No.
- 25 Q Why did you turn away from him?

- 1 A I just didn't want to look at this face anymore. I knew I was stuck where I was at.
- 2 There was nothing I could do.
- 3 A And, so, you said at that point, he penetrated you again?
- 4 A Yes.
- 5 Q All right. Was this again vaginally?
- 6 A Yes.
- 7 Q But you were facing away from him?
- 8 A Yes.
- 9 Q So, at this point, you had done two shots while you were at the hot tub place? Is that a
- 10 yes?
- 11 A Yes. I'm sorry.
- 12 Q And you had been drinking before that?
- 13 A Yes, ma'am.
- 14 Q What—What did you drink before that?
- 15 A I had a—like a large 22 ounce watermelon mimosa.
- 16 Q Okay. Where did that come from?
- 17 A He purchased it. I offered to give him my debit card to buy a drink, and he told me, no,
- Don't worry about it, he had it.
- 19 Q Where was that?
- 20 A That was at his home.
- 21 Q Was that all you had to drink that day?
- 22 A Yes, but I was on medications, as well.
- 23 Q What sort of medication?
- 24 A Phentermine and Vicodin.
- 25 Q So, you indicated that you were pretty intoxicated at the hot tub facility?

Yes, ma'am. 1 Α Do you remember everything that happened? 2 Q Not everything. 3 A What parts—are there points that you black out? Or how do you know you don't 4 Q remember? 5 6 From what I was told there's evidence that was at the hot tub that I don't remember. A 7 MR. BLANCHARD: Object at to foundation. Hearsay. BY MR. DOE: 8 9 Q Okay. 10 THE COURT: Hang on a second. Are you going to responded to the objection? 11 MR. DOE: I think her question was—I think her response was hearsay. I'm trying 12 to redirect. 13 THE COURT: I do too. 14 I'll sustain the objection. 15 16 BY MR. DOE: There isn't any particular point where you realize that you were blacked out it's just that 17 Q you may have learned things later? 18 19 MR. BLANCHARD: I would object to the leading nature of the question.

25 A I—I honestly—that could be everything.

Thank you.

I'll overrule that objection.

MR. DOE: I'm trying to clarify without eliciting hearsay, Your Honor.

THE COURT: I'm going to allow it for now.

- 1 Q Okay.
- 2 A I'm not sure.
- 3 Q There's-
- 4 A There's not any points that I remember blacking out-
- 5 Q Okay.
- 6 A -or anything like that. But it is a bit—I don't remember that conversation going home. I
- 7 don't remember once I got home eating dinner with my children.
- 8 Q Okay. You said that you don't remember how your bath suit top came off the second
- 9 time.
- 10 A Right.
- 11 Q You had a bathing suit top on?
- 12 A Yes.
- 13 Q Was it a two-piece bathing suit? Separate top and bottom?
- 14 A Yes.
- 15 Q Do you know how the bottoms came off?
- 16 A No.
- 17 Q Were your bottoms all the way off?
- 18 A I think so. I'm going to say yes-
- 19 Q Okay.
- 20 A -but I'm sure-
- 21 Q Do you know whether he used a condom?
- 22 A No, I do not.
- 23 Q Do you know whether he ejaculated?
- 24 A Yes, he did.
- 25 Q So, we kind of left off at the point where you were facing away from him. What

- 1 happened after that?
- 2 A He finished. He ejaculated. And then as soon as he did that he went onto the other side
- of the hot tub, and the phone rang to tell us that the time was up. And he got out of the
- 4 hot tub. I was still in the hot tub because he went to answer the phone. I was still in the
- 5 hot tub trying to find my clothes. And then he came back out and said we had like, I
- believe, 10 minutes is what the phone call said. He went in and used the bathroom and
- 7 got dressed. I went in and ran water over me in the shower and then put my other clothes
- 8 on—my dry clothes on. I left my bathing suit top on, but I put my dry shorts on.
- 9 Q Okay. And at that point, did you leave the hot tub place?
- 10 A Yes.
- 11 Q Did you immediately report this to the police?
- 12 A No.
- 13 Q How long was it before you reported it?
- 14 A The next day.
- 15 A Honestly, I was scared and didn't want to hurt my grandmother.
- 16 Q Your grandmother is his—is the Defendant's mother?
- 17 A Yes.
- 18 Q At the point which you eventually reported this, you went and had an examination at the
- 19 YMCA?
- 20 A Yes, ma'am.
- 21 Q Did you have, that you ever noticed personally, any injuries or soreness after this?
- 22 A Yeah, I was extremely sore afterwards. My muscles were extremely sore. Vaginally, no.
- I just know that my—I don't know if it was from the stress or from the actual act, but
- 24 my muscles were extremely sore.
- 25 Q What muscles?

Around my shoulders and my neck. 1 Α Did you ever had any marks on your neck from when he had his hands around you? 2 Q Not that I noticed. They did take pictures, but-3 A 4 Q Okay. A -I never noticed any. 5 Who's they? 6 Q 7 The YMCA, I believe. Α Okay. 8 Q 9 Α She did tell me that I had a mark on-10 MR. DOE: You can't tell what other people told you – THE WITNESS: Okay. 11 MR. DOE: -because that's hearsay. 12 Thank you. 13 I don't have any further questions for you. Thanks. 14 THE COURT: Mr. Blanchard? 15 16 MR. BLANCHARD: Thank you, Your Honor. Good afternoon. 17 THE WITNESS: Hi. 18 19 **CROSS- EXAMINATION** BY MR. BLANCHARD: 20 You spoke with a police officer related to this event, right? 21 Q 22 A Yes, I did. That was the Detective Cole from the Marquette City Police Department? Is that 23 Q 24 accurate? That was the second detective I spoke with. Yes. 25 A

- 1 Q And you spoke with her about this incident though, correct?
- 2 A Yes.
- 3 Q Okay. And you told her the truth?
- 4 A Yes.
- 5 Q And you didn't leave anything out?
- 6 A Not that I know of.
- Okay. And the events that occurred you're saying occurred on July 9, correct?
- 8 A It was the eighth or the ninth. I can't remember the exact date. It was the eighth or ninth,
- 9 whatever.
- 10 Q And-
- 11 A I know I spoke to somebody on the ninth, I believe.
- 12 Q You spoke to the police officers relatively close in time to when this occurred, or when
- you say it occurred, correct?
- 14 A Officer Palmer I did. I spoke to him the next day. He took my statement.
- 15 Q And then you spoke to the detective about a week later?
- 16 A Yes.
- Okay. The events were fresher in your mind back then than they are today, correct?
- 18 A It's possible.
- 19 Q You have used more than one name over the course of your life, true?
- 20 A Yes.
- 21 Q You've gone by Melissa Jones?
- 22 A Yes.
- 23 Q You've gone by Melissa Williams?
- 24 A Yes.
- 25 Q You've gone by Melissa Jones-Williams?

- 1 A No.
- 2 Q Never gone by Melissa Jones-Williams
- 3 A My Facebook is hyphenated Jones-Davis
- 4 Q Okay.
- 5 A But that's not a legal name. I've never used it legally.
- 6 Q And you've gone by Melissa Davis, correct?
- 7 A No. That's just a Facebook name. I'm getting ready to be married.
- 8 Q Okay. So, you've—you've used that name on Facebook, correct?
- 9 A On Facebook at this point, yes.
- 10 Q To identify yourself, correct?
- 11 A Yes.
- Q Okay. So, you're saying that you were at your grandmother's house on July 9<sup>th</sup>?
- 13 A Yes.
- 14 Q Around 5:30 in the evening, correct?
- 15 A Yes.
- 16 Q And you—it's your version that Thomas came home, correct?
- 17 A Yes.
- 18 Q And that's where Thomas is staying?
- 19 A Yes.
- 20 Q And when I say Thomas, I'm referring to Mr. Miller? You understand that, right?
- 21 A Yes. (Inaudible garbled).
- Q Okay. And he told you that he was going to the store?
- 23 A Yep.
- 24 Q And he asked if you wanted anything, correct?
- 25 A No. He said he was going to get a couple of drinks and I asked him if he would get me

- something, and I offered to get him my debit card so that he could get me something.
- 2 Q Thank you. So, you—you—he told you that he was and you asked him to also get you
- 3 something, correct?
- 4 A Yes.
- 5 Q And when we're talking about something we're talking about alcohol, correct?
- 6 A Yes.
- 7 Q You said that he invited you back for barbeque and beer, is that correct?
- 8 A Yes.
- 9 Q It's barbeque and beer at that house that you were at, correct?
- 10 A Yes.
- 11 Q The house that belongs to your grandmother?
- 12 A Yes.
- 13 Q His mother?
- 14 A Yes.
- Sometime prior to barbequing and drinking beer, the plans changed to go to the hot tubs,
- is that true?
- 17 A Yes.
- Now, you testified on direct that you were having a "really bad day", correct?
- 19 A Yes.
- 20 Q Why were you having a really bad day?
- 21 A My fiancé and I were not getting along that day.
- 22 Q What do you mean by not getting along that day?
- 23 A We had been arguing. We weren't getting along.
- 24 Q You called the police on him, correct?
- 25 A The night before, yes.

- 1 Q And had him arrested for domestic violence the night before, correct?
- 2 A Yes.
- 3 Q As a result of your call to the police?
- 4 A Yes.
- 5 Q And you agreed to go to the hot tubs with Mr. Miller?
- 6 A Yes.
- 7 Q And you didn't find that to be weird?
- 8 A No, he's my uncle. Why would I?
- 9 Q Right. You testified that you drank some alcohol that day?
- 10 A Yes.
- 11 Q And you also took some prescription medications, correct?
- 12 A Yes
- 13 Q You took Phentermine?
- 14 A Phentermine, yes.
- 15 Q That was in the morning, correct?
- 16 A It was about noon when I took it.
- You didn't tell the detective you took it around nine in the morning?
- 18 A I take several doses a day.
- 19 Q Okay. So, you're saying you take several doses a day?
- 20 A Yes.
- 21 Q And you take one of them at noon?
- 22 A I take them every four hours, so I probably took one at nine and one at noon.
- Q Okay. And you took a Vicodin, correct?
- 24 A Yes.
- 25 Q You took that around 4 p.m.?

- 1 A Yep.
- 2 Q And Mr. Miller came to the house around 5:30, correct?
- 3 A Yes.
- 4 Q About 90 minutes later?
- 5 A Yes.
- 6 Q You're prescribed the Vicodin I assume?
- 7 A Yes.
- 8 Q By a doctor?
- 9 A Yes.
- 10 Q And they gave you direction on how to take it, correct?
- 11 A Yes.
- 12 Q Do you take it as directed?
- 13 A Yes.
- 14 Q Do you take more than directed?
- 15 A No.
- 16 Q So, that day you took it as prescribed, correct?
- 17 A Yes.
- 18 Q How much were you prescribed to take?
- 19 A I'm allowed four to six capsules every—or two to six—capsules every four to six hours.
- 20 Q So you took two capsules at four?
- 21 A I took one.
- 22 Q You took one capsule at 4 p.m.
- 23 A I take it every four hours.
- 24 Q But I'm asking about this day.
- 25 A Yes.

- 1 Q Did you take one capsule at 4 p.m?.
- 2 A Yes.
- 3 Q And what dosage is a capsule?
- 4 A 7.5 milligrams.
- 5 Q So, it's 7.5 milligrams of Vicodin.
- 6 A At 325 of the (inaudible garbled). It's called Norco. The medication is Norco-
- 7 Q Right.
- 8 A -also known as Vicodin.
- 9 Q Right. And, so, it's a seven and a half of the—and—of the opiate-
- 10 A Yes.
- 11 Q -and 325 of the Tylenol, correct?
- 12 A Yes.
- 13 Q This isn't the first time you've accused somebody of raping you?
- MR. DOE: Objection. Relevance.
- MR. BLANCHARD: She's made-
- THE COURT: Counsel?
- MR. BLANCHARD: She's made prior false allegations.
- THE WITNESS: They were not false allegations.
- THE COURT: Yeah, I think that's—I'm going to sustain the objection for now.
- 20 MR. BLANCHARD: Thank you.
- 21 BY MR. BLANCHARD:
- 22 You talked to the police office about a conversation that you had with Mr. Miller via text
- 23 message, correct?
- 24 A Yes.
- 25 Q And you—you guys had conversed throughout the day, true?

- 1 A Not via text, no.
- 2 Q But both in person-
- 3 A Person-
- 4 Q -and via text, correct?
- 5 A Yes.
- 6 Q Did you tell the officer the entire truth about what your conversations via text message
- 7 with Mr. Miller were?
- 8 A As much as I remember of it. Yes.
- 9 Q You have these text messages on your cell phone, correct?
- 10 A I did, yes.
- 11 Q And your cell phone was wiped, or cleared, or reset before the police had an opportunity
- to look at it, correct?
- 13 A I haven't wiped my phone. No.
- 14 Q You didn't delete any of the text messages?
- 15 A I deleted them but my phone has not been wiped.
- So, you deleted the text messages before the police were able to look at them?
- 17 A Yeah, I deleted them that night.
- Why would you delete text messages from somebody who you say raped you?
- 19 A I didn't want my fiancé to see them.
- 20 Q You told your fiancé, right?
- 21 A I told him the next day.
- 22 Q He was the first person you told, right?
- 23 A Yes.
- 24 Q And you deleted the text message before you could even show them to him?
- At that point, I was still intoxicated and I didn't know what to do. I even text messaged

- not to say anything to anybody, because I didn't want my grandmother to find out and be
- 2 hurt by all of this.
- 3 Q So, you—you texted him not to say anything, correct?
- 4 A Yes.
- 5 Q And that—that's the thing to which he responded asking you what you were talking
- 6 about, right?
- 7 A Yeah.
- 8 Q To which you said, exactly, right?
- 9 A No, he said exactly.
- 10 Q You're saying he said exactly?
- 11 A Yeah.
- 12 Q Do you remember saying to him, glad we could chat, I feel better?
- 13 A No. That doesn't mean that it didn't happen, but like I said, I don't remember anything
- from when I got home that night. I don't even remember having dinner with my children.
- 15 Q So, you may have said to him, glad we chatted, I feel better?
- 16 A It's possible.
- 17 Q After you say you were raped by him?
- 18 A Yes.
- 19 Q So, after you say this rape occurred in the hot tub, you—a phone call came from the front
- desk for something, right?
- 21 A Yes
- 22 Q You got out of the hot tub?
- 23 A I—Yes.
- 24 Q And you went and took a shower, correct?
- 25 A I rinsed off in the shower, yes.

- 1 Q When you rinsed off in the shower you also shampooed your hair, correct?
- 2 A Just my hair, yes.
- 3 Q So, you shampooed your hair?
- 4 A Yes.
- 5 Q And Thomas was still in the room, correct?
- 6 A He was in the bathroom.
- 7 Q Okay, Thomas was in the bathroom while you were shampooing your hair?
- 8 A Yes.
- 9 Q And you're saying that Thomas had just raped you, correct?
- 10 A Yes.
- 11 Q Why didn't you go to the front desk and ask for help?
- 12 A I just wanted to go home. You can pick at me all you want, but I just wanted to go
- home and have it be over with, and be in a place where I could be comfortable.
- 14 Q And you wanted to go home and have Thomas drive you home?
- 15 A I didn't have a choice. I didn't know where I was at. I was intoxicated.
- Well, let—let's talk about the intoxication. You said that you drank what Thomas
- brought you, correct?
- 18 A Yes.
- 19 Q And you say that Thomas brought you a single beverage, correct?
- 20 A No, he bought me two-
- 21 Q I'm sorry.
- 22 A -at the hot tubs and one at his home.
- 23 Q Yeah. That was a poor question. When you're at this house you say he brought you—
- purchased for you one alcoholic beverage, correct?
- 25 A Yes, A 22 ounce watermelon mimosa Smirnoff.

- 1 Q Right. That's a wine cooler type thing, correct?
- 2 A Yes.
- 3 Q And you drank that in its entirety, correct?
- 4 A Yes.
- 5 Q In addition to that you're saying you drank two shooters, correct?
- 6 A Yes
- 7 Q Those are like that little maybe two inch bottles?
- 8 A Yes.
- 9 Q The ones you see by check-outs at gas stations and that sort of thing?
- 10 A I guess. Yes.
- Okay. And one of those was something called a Kinky Pinky, and then there was
- another one, correct?
- 13 A Yes. It was like Chata Rum or something. It was a rum in a white bottle with gold
- 14 letters.
- 15 Q Like Rum Chata?
- 16 A Yeah, maybe that's what it's called. I'm not sure.
- 17 Q Okay. And you drank that, correct?
- 18 A Yes.
- 19 Q And that's all the alcohol you had that night, correct?
- 20 A Yes.
- 21 Q You are in your 30's, correct?
- 22 A 33.
- 23 Q And how tall are you?
- 24 A Five, five.
- 25 Q And how much do you weigh?

- 1 A 285.
- 2 Q And you're saying that you got so intoxicated that you couldn't remember everything
- 3 based off one 22 ounce Smirnoff and two shooters?
- 4 A Yes. I don't drink.
- Well, wait a minute. You said you don't drink and then you said you normally don't
- 6 drink.
- 7 A I very rarely drink. The last time I drank was my birthday which was in April and I was at
- 8 Home with my fiancé. I don't drink on a regular basis. I have a very low tolerance for
- 9 alcohol.
- Okay. I want to be clear on the timeline for the drinking. You said that you had the
- Smirnoff at the house that Mr. Miller was at?
- 12 A Yes.
- 13 Q Sometime around 5:30, is that right?
- 14 A It was between the time that he bought it and the time that I left to take my kids back
- 15 home, so, yes.
- Okay. And then—so you had that and then there was a break until you got to the hot tubs,
- 17 correct?
- 18 A Yes.
- 19 Q And then at the hot tubs is where you had these two shooters, correct?
- 20 A Yes.
- 21 Q And that would have been –you left the hot tubs a little bit after eight, correct?
- 22 A It would have been a total of maybe two hours later-that-
- 23 Q So, you're saying that three—the three drinks over two hours go you like blackout
- 24 drunk?
- 25 A I didn't say I was blackout drunk. I just said that I was highly inebriated. So, yes-

- 1 Q Were you-
- 2 A -I was intoxicated.
- Were you drunk enough that you shouldn't have been driving?
- 4 A Yes, I was. And I didn/t drive.
- When you're at this hot tub place there's a shower near the hot tub, correct?
- 6 A Yes.
- 7 Q And that's the shower that you reference when you say you were shampooing your hair,
- 8 correct?
- 9 A Yes. It's in the other room outside of the hot tub.
- 10 Q And that's separate from the bathroom, correct?
- 11 A Yes.
- And, so, when you're in there showering and you say Mr. Miller's in the bathroom, you
- could have gone out and he wouldn't have noticed, correct?
- 14 A Gone out where?
- 15 Q Out to the lobby.
- 16 A It's possible, yes.
- 17 Q So, you have been at this house that you say Mr. Miller was living at doing work for his
- grandmother, correct?
- 19 A For my grandmother.
- 20 Q Excuse me. Yes, for your grandmother, for his mother, correct?
- 21 A Yes.
- 22 Q And that work was painting work, correct?
- 23 A Yes.
- 24 Q You left that place around six o'clock right?
- 25 A Yes.

- 1 Q And you drove from that place to your home, correct?
- 2 A Approximately six minutes away, yes.
- 3 Q Your children were at this mother's house, correct?
- 4 A They were. I took them home with me at six o'clock.
- 5 Q Okay. And you say you live six minutes away?
- 6 A Approximately,
- 7 Q Do you live within Marquette?
- 8 A No, we weren't in Marquette. That house is in Harvey.
- 9 Q Okay. So, you drove from there to?
- 10 A My house-
- 11 Q Your house.
- 12 A -is in Harvey.
- 13 Q How long were you at your house?
- 14 A Maybe a half hour tops.
- 15 Q What did you do while you were at your house?
- 16 A I showered and got a bathing suit.
- 17 Q And then you returned to that house?
- 18 A Yes.
- 19 Q From there—well, let me be clear. At the point that you come back you said you felt
- 20 tipsy, correct?
- 21 A Yes.
- 22 Q So, when you drove your kids to your house and when you drove back you felt
- 23 intoxicated?
- 24 A Yes.
- 25 Q After you got back to this house that Thomas was at, he drove to the hot tubs-

- 1 A Yes.
- 2 Q -is that—that's where you stopped and you got the alcohol shooters, correct?
- 3 A Yeah.
- 4 Q And then you arrived at the hot tub place at about 7:11 p.m., is that correct?
- 5 A About quarter after seven, yes.
- 6 Q So, when we talk about the shooters, the little alcoholic shooters that you drank, you
- said that you had two of them before you say the sex occurred, correct?
- 8 A Yes.
- 9 Q And you drank those while you were having "normal conversation", right?
- 10 A Yes.
- 11 Q That's how you characterized the conversation, right?
- 12 A Yes.
- 13 Q And that was prior to any sexual contact, correct?
- 14 A Yes.
- 15 Q You were discussing pornography, correct?
- 16 A Yes.
- 17 Q And websites where you could get pornography, correct?
- 18 A Yes.
- 19 Q And you told Mr. Miller about your use of a site called Adult Friend Finder, correct?
- 20 A Yes.
- 21 Q Now, it's your position that then Thomas asked you if he could see your breasts, correct?
- 22 A Yes
- 23 Q And you showed them to him?
- A My top was pretty much already off, and yes, I showed them to him.
- 25 Q What do you mean your top was already pretty much off?

- 1 A I have—it was a tankini so it was floating up in the water.
- 2 Q And-
- A A tankini is like a bikini, but it's got a flap that covers your stomach and it was already
- 4 floating up in the water.
- 5 Q And, so, you—is it your testimony that you showed him your breasts because it was
- 6 floating up so, you know, why not?
- 7 A No, I don't have any problem with my sexual nature. I'm not a shy person. He's my
- 8 uncle. I have nothing to hide. I'm open with my sexuality.
- 9 Q So, you—you showed him your breasts because he's your uncle and you have nothing to
- 10 hide?
- 11 A Yeah. I looked at his penis too. I wasn't really too—it's a penis. I wasn't offended by it,
- or thinking that anything sexual was going to happen. I'm a medical assistant. I'm very
- open with my body.
- Q Okay. So, you were more comfortable showing your breasts to your uncle because you're
- a medical assistant?
- 16 A I work in the medical field. I see it every day. It's not anything that I'm sure he hasn't
- seen.
- 18 Q Can we agree that exposing your own breasts to an uncle is different than what happens
- in a medical setting?
- 20 A It's a little different. I did find it a little odd. But, again, I'm not going to no—I have
- 21 nothing to hide.
- 22 Q So, you want me-
- A I felt comfortable. He's a family member. I didn't think he was going to take it anywhere.
- Q Okay. So, you exposed your breasts to him by lifting your top, correct?
- 25 A Yes.

- 1 Q And you did that so that your uncle could see your breasts?
- 2 A Yes.
- 3 Q You testified that after you showed your breasts to Thomas you say he moved across the
- 4 hot tub, correct?
- 5 A Yes.
- 6 Q So, before you exposed your breasts he was on different side of the hot tub than you
- 7 were?
- 8 A Yes.
- 9 Q And then when you exposed your breasts you say he came across the hot tub?
- 10 A Yes.
- 11 Q The hot tub was full of water, right?
- 12 A Yes.
- 13 Q So, he had to sort of float across?
- 14 A He could touch the bottom. He walked across, I guess. I—I don't know.
- Okay. But he couldn't have reached you from where he was sitting, correct?
- 16 A No.
- 17 Q And when you exposed yourself, you could still see Thomas, correct?
- 18 A Yes.
- 19 Q And you could see him moving towards you, correct?
- 20 A Yes.
- 21 Q And when you saw him moving towards you, you didn't put your top back down?
- 22 A No. When he touched me I put my top back down, and I grabbed the shooter.
- 23 Q Right. But you saw him coming towards you when you had your breasts exposed,
- 24 correct?
- 25 A Yes.

- 1 Q Okay. And you didn't put the top back down?
- 2 A No.
- 3 Q You didn't climb out of the hot tub?
- 4 A No.
- 5 Q You didn't say don't touch me?
- 6 A No.
- 7 Q And you say you pulled your top down after he touched your breasts, correct?
- 8 A Yes.
- 9 Q After you pulled the top down, you said you reached over and grabbed two shooters, and
- you gave him some more alcohol?
- 11 A I gave him one and I took one.
- Q Okay. So, in order to get him to stop this you gave him more alcohol?
- 13 A It was his alcohol. He wanted to drink it.
- 14 Q Well, you handed it to him, right?
- 15 A Yes.
- After you gave him the alcohol you didn't say anything to him about stopping, correct?
- 17 A He left me alone. He went back to his own side of the hot tub.
- 18 Q You didn't say anything to him?
- 19 A No, I didn't feel I needed to.
- 20 Q Now, you testified that when Thomas got in the hot tub he took his underwear off,
- 21 correct?
- 22 A After he was in the hot tub, yes.
- 23 Q Right. And that—to be clear from you version of events, that occurred prior to any
- sexual contact, correct?
- 25 A Yes.

- Prior to discussing any of the sexual stuff, correct? 1 Q A 2 Yes. In fact, you told him that you didn't mind? 3 Q Again, I'm perfectly normal. He's my uncle. Don't really see any concern. He was under 4 A the water. And he was on the other side of the hot tub. 5 You didn't have any—you didn't think there was anything odd about sitting in a hot 6 Q tub naked with your uncle who was naked, correct? 7 8 A No. 9 Q Okay. So, you said that there was a time where you saw Thomas's penis, correct? 10 Α Yes. Q And you said that was because he stood up and showed it to you? 11 12 A Yes. And then sat back down? 13 Q Α Yes. 14 And after he sat back down you had normal conversation again? Q 15 16 Α We were still talking about things that we were talking about before with the porn sites stuff like that. It was not anything to do sexually between him or I. 17 Okay, So I want to be clear. When you—Like when you tell the detective you were 18 O 19 having normal conversation, are you referring to conversation about porn sites, or conversation about the weather, or something else? 20 21 A His conversation with me was about how he still has feelings in it, and that the
- It's normal conversation. It's about a penis. Like I said, I'm a medical assistant. I don't

- 3 Q You say that after he sat down you had a normal conversation, you mean you had a
- 4 conversation about his penis?
- 5 A Yes.
- 6 Q About your uncle's penis.
- 7 A Yes.
- 8 Q Now, this time when you say you spotted his penis that occurred after you say he
- 9 touched your breasts, correct?
- 10 A Yes. And I didn't spot it. He showed it to me.
- Okay, After you saw the penis that occurred after the –the—you say he touched your
- breast, correct?
- 13 A Yes.
- 14 Q Now, I asked you specifically about when you say he was touching your breast. But, at
- any point during this process, did you ever tell him to stop?
- 16 A No.
- 17 Q Did you ever say no?
- 18 A No.
- 19 Q Did you ever say this is gross?
- 20 A No, I didn't-
- 21 Q Did you ever say-
- 22 A -say anything.
- 23 Q Other than the normal conversation, right?
- 24 A Other than the conversation that we were having. I didn't tell him to stop, no.
- 25 Q Well, you talked about a website where you posted your breasts, correct?

- 1 A Yes, but we also talked about working on house, we also talked about him working
- as a police officer, we also talked about a lot of other things. It wasn't all about sex.
- 3 Q Okay. But I want to be clear. Parts of the normal conversation you had included you
- 4 posting pictures of your breasts, correct?
- 5 A Yes.
- 6 Q On the internet?
- 7 A Yes.
- 8 Q You talked about his penis, correct?
- 9 A He talked about his penis, yes.
- 10 Q Well, you had the conversation about it, right?
- 11 A I guess. (Inaudible Mr. Blanchard talking over witness).
- 12 Q You had a conversation about-
- 13 A He was telling me what it was like to be three-quarters of the way circumcised.
- 14 Q You had a conversation about him not wearing underwear? Just being completely naked,
- right?
- 16 A We didn't have a conversation about it. He asked me if it bothered me and I told him no.
- Okay. You told your fiancé about this the next day, correct?
- 18 A Yes.
- 19 Q What prompted you to tell him?
- 20 A Because I felt really dirty and I don't lie to him.
- 21 Q You don't like to him at all?
- 22 A No.
- 23 Q Not about anything?
- 24 A No.
- 25 Q Ever?

1	A	No.
2	Q	Now, I'm—I guess I want to be clear. The—The person you told the next day, is that the
3		same person you had arrested the day prior?
4	A	The day prior to the actual incident, yes.
5	Q	You had him arrested on July 8?
6	A	Yes, I believe that's the date. It was the day prior to the incident, yes.
7	Q	And you told him about this on July 10?
8	A	The day that I reported it, yes.
9	Q	You had him arrested for domestic violence, right?
LO	A	No. He was arrested because I asked him to leave, and the police had arrested him
L1		because he had no place else to go. So, they took him to jail and they drop—they
L2		dropped all the charges. The police officer said that was the only option that he had
L3		because he had no place else to go for the night.
L4	Q	You didn't tell the police that he had physically abused you?
L5	A	No, I did not.
L6	Q	You didn't tell the police that you got in an argument and that he had hit you in the face?
L7		MR. DOE: Objection. Relevance?
L8 L9		MR. BLANCHARD: She had taken the position that she didn't have him arrested. It's a prior inconsistent statement.
20		THE WITNESS: I did have him arrested.
21 22		THE COURT: Hang on a second, ma'am. I'm going to need to make a ruling on the objection first.
23		The basis of the objections first is?
24 25		MR. DOE. That it's irrelevant to what happened between her and her fiancé the day before this incident.

1	THE COURT: Mr. Blanchard?
2	MR BLANCHARD: Yeah, I mean, the issue is—I've got the incident
3	report from when she reported it, and she made allegations of domestic violence against
4	him that day. That's—And, so, we've got a prior inconsistent statement here. She's
5	taking the position she didn't accuse him of domestic violence, and she told the police
6	that she did. And, so, I think that I get to ask her about the question so that I can later
7	impeach her with the police officer's testimony.
8	MR. DOE: On an ancillary case at preliminary examination, Your
9	Honor, this just seems really far afield.
10	THE COURT: Well—And that's kind of what I'm getting at.
11	Why is that relevant to the incident that we're here for today?
12	MR. BLANCHARD: I think People v Kevorkian and Yost say that it's
13	incumbent upon the examining magistrate to access credibility of the complainant at the
14	examination, and I think it goes to her credibility.
15	THE COURT: Okay.
16	I'm going to—I'm going to overrule the objection. I'm going to allow it,
17	But let's not dwell on this. That's not why we're here.
18	MR. BLANCHARD: Thank you, Your Honor.
19	THE COURT: I mean, I understand her credibility is at issue-
20	THE WITNESS: Can I answer the question-
21	THE COURT: - (inaudible – talking over witness) case.
22	Let him ask the question again if you would please, Mr. Blanchard and
23	then yes, you may, answer the question.
24	THE WITNESS: Thank you.
25	BY MR. BLANCHARD:

- 1 Q Isn't it true that you told the police officers that your fiancé had physically assaulted you?
- 2 A No. I told the office that my fiancé had threw something, and that it hit me in the face,
- And that my nose—he had either gotten me with his fingernail, and that my nose was
- 4 bleeding. The officer asked him to leave for the night, and he had not place to go, so he
- 5 was asked if he went to jail that night he was released the next day on bond.
- 6 Q So, you told-
- 7 A And the case was dropped.

- 9 A That his fingernail got my nose. Yes, that is what I told the officer.
- Okay. There was some discussion between the Prosecutor when she was asking you
- questions and yourself about whether a condom was used, right? Do you remember that?
- 12 A Yes.
- Okay. And I think—what was your answer to the Prosecutor?

8		DIRECT EXAMINATION
9	BY I	MR. BLANCHARD:
10	Q	Do you know Melissa Jones?
11	A	Yes.
12	Q	How long have you known her?
13	A	Ever since she was an infant, basically.
14	Q	Okay. Do you have an opinion about her character for truthfulness?
15	A	Yes.
16	Q	And what is your opinion?
17	A	I wouldn't trust her—a word that she says about anything.
18		MR. BLANCHARD: I would pass the witness.
19		MR. DOE: I have no questions for this witness.
20		THE COURT: Thank you.
21		May this witness be excused?
22		MR. BLANCHARD: No objection.
23		THE COURT: Thank you, Mr. Jones.
24		You're free to go.
25		MR. BLANCHARD: We don't have any additional proofs, Your

1	Honor.
2	THE COURT: Any rebuttal, counsel?
3	MR. DOE: NO.
4	Thank you, Your Honor.
5	THE COURT: Okay.
6	MR. DOE: At this point, I would move for bind over on the three
7	counts on the felony complaint.
8	THE COURT: Any closing, Mr. Blanchard?
9	MR. BLANCHARD: Yes, Your Honor.
10	Thank you.
11	I think, as I've indicated before, it's incumbent upon the examining
12	Magistrate to assess credibility.
13	And what we're looking at here is, Count One charges criminal sexual
14	conduct in the first degree with the allegation that a penetration occurred during
15	the commission of a felony, that being assault by strangulation.
16	She didn't make out facts for an assault by strangulation. One, she says
17	that this thing that occurred didn't cut off her ability to breathe, it happened
18	somewhere between five and 10 seconds, that she—there was no other assaultive
19	behavior that occurred around this thing she says that they're trying to elevate
20	this to a CSC one with.
21	I don't think the Court can make a finding here that there's probable cause
22	believe that an assault by strangulation occurred, and that Mr. Miller committed
23	it.
24	I think you also have to take into account her credibility when assessing
25	that and look at what she says happened. She says she's in a hot tub with this

1	guy, that she exposes her breasts, that she gives him alcohol, that he's in there
2	naked and she's okay with it. There's all of this, by her testimony, sexual stuff
3	going on that then somehow she says, well, but I didn't want this thing to happen.
4	Now, I understand as charged CSC three by incest, consent is not an issue.
5	I think it does, however, bear on her credibility for the Count One, the CSC one.
6	I don't think the Court can bind over on Count One. I think there's a real
7	credibility question, and I think the Court would be justified on not biding over
8	On Counts Two on Three either.
9	THE COURT: Anything further, Mr. Doe?
10	MR. DOE: Just briefly, Your Honor.
11	Assault by strangulation has three elements. Battery, which is
12	forcible, violent or offensive touching. That is was intentional and the battery was
13	committed by strangulation or suffocation. That means intentionally impeding
14	normal circulation of the blood or breathing by applying pressure on the throat. I
15	think—on the throat or neck. I think her testimony does establish that element,
16	and I would ask for bind over on all three counts as charged.
17	THE COURT: All right.
18	I'm going to take a few minutes to review my notes given the
19	extensive testimony over the last approximately almost two hours. I'm just going
20	to need a few minutes. I won't need long.
21	Whether or not he goes back to holding, he can stay here as far as
22	I'm concerned, as long as you limit his contact in accord with the policy.
23	I will hope to be back by about 3:30 or so.
24	And we can go off the record.
25	MR. BLANCHARD: Thank you, Your Honor.

1	THE COURT: Thank you.
2	(At 3:19 p.m., Court recessed)
3	(At 4:01 p.m., Court recessed)
4	THE COURT: Okay.
5	We are back on the record in the matter of the People of the State of
6	Michigan as to Thomas Miller. File 151067FY.
7	The Court had taken a recess to review not only the Complaint, but I did
8	also want to look closer at MCL 750.84 (10 (b) and, in particular, the definition of
9	strangulation or suffocation.
10	I wanted to review my notes.
11	I did take longer than I anticipated and I certainly appreciate everyone's
12	patience this afternoon while I carefully considered all the information that was gathered
13	here this afternoon.
14	The Court is going to find as to Court One that there is probable cause to
15	believe that the crime of criminal sexual conduct, first degree, in particular, that Mr.
16	Miller did engage in sexual penetration, that being penis vagina with Melissa Jones under
17	circumstance involving the commission of another felony, that being assault by
18	strangulation.
19	There was testimony that he did place his hands around her throat, that it
20	did impede her normal breathing, and that there was, again, an application of pressure on
21	her throat at least to the amount required that it was difficult for her to breathe.
22	So, I'm going to find probable cause that he did—that there was an
23	offense committed. Probable cause that he was the one who committed this offense.
24	Courts Two and Three with regard to the issues of probable case. I don't
25	want to say they were a little bit easier, but they were a little bit easier, because that

1	simply requires the sexual penetration, penis vagina between Mr. Jones and Mr. Miller,
2	given their relationship, because they are related by blood or affinity to the third degree.
3	Mr. Miller is Ms. Jones' maternal uncle, the brother of her mother.
4	So, I am going to find probably cause that the crime of criminal sexual conduct,
5	third degree, was committed in Count Two in that Mr. Miller did engage in sexual
6	penetration, that being penis vagina with Melissa Jones and, again that they were related
7	by blood or affinity to the third degree. Probably cause to believe that Mr. Miller was the
8	one who committed the offense.
9	And that would be the same as to Count Three given that there appeared to have
10	been at least two episodes of penis vagina sexual penetration.
11	So, Mr. Miller will be bound over to the Circuit Court given that these offense are
12	not cognizable by the District Court.
13	A date will be schedule for him to appear in—in the Circuit Court on the three
14	counts as charged.
15	Is there anything further, counsel?
16	MR. DOE: Nothing for the People.
17	Thank you, Your Honor.
18	MR. BLANCHARD: If I can just get clarification on the bind over decision.
19	The testimony I heard and I think the Court's findings was that there were two
20	episodes, you're binding over on three counts? Are you biding over on Count Two as an
21	alternative to Count One, or are you binding over on three separate counts?
22	THE COURT: Three separate counts.
23	MR. BLANCHARD: Thank you.
24	THE COURT: The first one being the act of the sexual intercourse during the
25	commission of the strangulation—the assault by strangulation.

1	Count Two, the act of engaging in sexual intercourse while they were facing each
2	other given their relationship.
3	Count Three, the act of sexual intercourse we're to—I don't know how—from the
4	back as she said, or from behind and given their relation.
5	MR. BLANCHARD: Thank you, Your Honor.
6	THE COURT: Thank you.
7	MR. DOE: Thank you.
8	THE COURT: Thank you.
9	MR. BLANCHARD: Is the Court setting an arraignment on the information
10	(inaudible – Court talking over Mr. Blanchard)-
11	THE COURT: I will not be.
12	MR. BLANCHARD: Okay
13	THE COURT: I know we do it a little bit differently when counsel's retained.
14	I don't know how soon, Mr. Blanchard, you will know that.
15	Any indication?
16	THE CLERK: He can go to the fourth floor clerk's office and get a date.
17	THE COURT: Oh, apparently, you can go straight upstairs today and know of
18	that date today.
19	MR. BLANCHARD: Great. Thank you, Your Honor.
20	THE COURT: Okay.
