Notes/Narratives

SUMMARY:

On May 11, 2019, Melissa Jones reported that her uncle, Thomas Miller sexually assaulted her at the Hot Tub House located at 3500 W. Huron St., Marquette, MI 49855. The suspect in this incident, Thomas Miller, has not been located at this time. No arrest has been made in this case and prosecution is desired.

INFORMATION:

On May 11, 2019, at approximately 1543 hours, I was dispatched to a CSC complaint that occurred at 3500 W. Huron St., Marquette, MI 49855, the Hot Tub House. Dispatch advised me that the CSC occurred on May 10, 2019 and the suspect was Thomas Miller. I was advised that not only did Miller assault Jones, but he also physically choked her. I was advised that both Jones and Miller live in Marquette. I was then advised that Jones was going to need a CSC kit completed and did not have a ride to the YWCA. I was advised that I needed to pick Jones up from 6983 W. Lake Rd. in Marquette.

ARRIVAL:

I arrived at 6983 W. Lake Rd. in Marquette and made contact with Melissa Jones. Jones was able to provide me with clothing that she had worn on May 10, 2019, the night of the incident. This clothing consisted of a bikini top, bikini bottoms and a pair of plaid shorts. These items were placed in a brown paper bag. I then transported Jones to the YWCA where I interviewed her and she was examined by a nurse.

INTERVIEW WITH VICTIM:

Jones stated that on May 10, 2019, she was helping her grandmother at her grandmother's rental house in Marquette. Jones was unsure of the address of the rental house, but stated she believed it was on Capital Avenue.

Jones stated that she had been at her grandmother's house helping for a good portion of the day. Jones stated that her uncle, Thomas Miller, came to her grandmother's house where he was currently staying at approximately 1730 hours. Jones stated that Miller came downstairs to where she as painting and informed her that he was going out to get some beers. Jones stated that she was going to get her credit card so that he could get her something as well. Jones stated that Miller insisted on buying alcohol for her. Jones told me that Miller came back from purchasing alcoholic beverages and it was approximately 1800 hours.

Jones stated that she was drinking Smirnoff Watermelon Mimosa that Miller had purchased for her while she was finishing up the painting in the basement of her grandmother's house. Jones told me that Miller invited her for barbeque and beer. Jones stated that she agreed to barbequing and hanging out with Miller that night. Jones told me that at the last minutes, Miller stated that his back hurt and asked her if she wanted to go to the hot tubs in Marquette at the Hot Tub House located at 3500 W. Huron St., Marquette, MI 49855. Jones stated that she agreed to go to the hot tubs with Miller stating that she did not think anything weird of it, because it was her uncle.

Jones stated that she went to her home and changed into her bathing suit and put shorts on over her bathing suit. Miller picked Jones up and they stopped at the party store at the corner of Lake and Mackinac. Jones stated that when they arrived at the party store, Miller offered to buy her more alcohol. Jones stated that she did not care what Miller got for her, because she had already drank 22oz of Smirnoff Watermelon Mimosa. Jones also told me that she had taken her prescription Vicodin at approximately 1600 hours as well as Phentermine. The Phentermine was taken at approximately 1930 hours.

Jones stated that they left the party store and arrived at the hot tubs at approximately 1910 hours and the reservation was for 1900 hours. Jones stated that she charged her card and Miller gave her twenty dollars in cash. Jones said that when they entered the Hot Tub House, they made a right and walked right down the hall to an outside room with a fireplace and tiki torches. Jones advised me that she took her shorts off and got into the hot tub wearing the bikini that she was already wearing.

Jones advised me that Miller was wearing a dark gray t-shirt that was a crew neck and possibly cargo shorts. Jones said that Miller took off his clothes until he was down to nothing, but his light blue brief underwear. Once Miller was in his underwear, Jones stated that he got into the hot tub. Jones stated that she thought it was a little weird that Miller was in his underwear while he was in the hot tub with her, but she did not say anything about it. Jones did say that Miller said to her, "I don't have a bathing suit."

Once in the hot tub, Miller pulled out four shot bottles. Two of the shot bottles were named "kinky pinky." The other two shot bottles were some sort of coconut rum. Jones advised me that she drank one of the shots of kinky pinky. Jones stated that she was sitting on the stairs of the hot tub and Miller took his underwear off while he was still underwater stating, "Do you mind? I am still under the water." Jones stated that at this point she still didn't care too much, or think too much of it, because Miller was still under the water and not exposing himself to her.

Jones then explained to me that Miller began to tell her about his penis. Jones stated that Miller explained that his penis was circumcised on the top and not the bottom. Jones said that Miller said that his penis was unique and then pulled it out of the water and showed her. After talking about his penis and showing her, Miller requested that she take her top off. Jones told me that she did not take her top off at that time. Miller then brought up the fact that Jones used to be on a website called the Adult Friend Finder and he knew she had a picture of her boobs on that site. Miller insisted that he wanted to see her breasts. Jones stated that she caved in and showed Miller

her breasts, because she did not want to "piss him off" because he was her ride and she felt that she would not have any way to get back home and did not want to be stranded.

When Jones showed her breasts, Miller grabbed them with both hands and fondled them and said, "Yep, they're pretty perfect." Jones stated that she put her top back on and Miller quit touching her at this point.

Jones stated that they talked about miscellaneous stuff in the hot tub for several minutes and then Miller swam by her and took her top off and started playing with her breasts. Miller also pulled her body to him so that her body was rubbing against his erect penis. Jones stated that Miller slid her bikini bottom off and was putting his fingers inside of her vagina. Jones stated that Miller put his penis inside of her vagina and put his hands around her throat for approximately one minute. Jones stated that she did not pass out when Miller's hands were around her throat. Jones said that when Miller's hands were around her throat, he was trying to kiss her and stick his tongue in her mouth.

While Miller had his penis inside of Jones' vagina, Miller said, "Why won't you fucking come?" Jones stated that the whole time while Miller was sexually assaulting her, she was not looking at him and she was trying to push him away but could not due to the fact that they were in a hot tub and he was stronger than her. Jones told me that she never told Miller to stop when he was putting his fingers in her vagina and putting his penis in her vagina and trying to kiss her, stating that she was afraid of what Miller may be capable of and she did not want to upset him.

Jones stated that she was able to turn and try to get away from Miller; however, he grabbed her and put his penis in her vagina from behind and ejaculated inside of her vagina. Jones stated that after Miller ejaculated, he let go of her and went to the other part of the hot tub. Jones stated that she put her bikini bottoms on and got in the shower; however, she did not wash herself. Once she got out of the shower, she took off her bottoms and put on her shorts that she was originally wearing over her bikini.

I asked Jones how long Miller had his penis inside of her. Jones stated that Miller had his penis inside of her for approximately ten minutes. I asked Jones if there was any sort of bleeding in her vaginal area as a result of this incident. Jones told me that there was no bleeding as a result of this incident. I also asked Jones if she had any other visible injuries as a result of this incident. Jones said that she had no injuries. Jones stated that after she got out of the shower she and Miller left the Hot Tub House and they did not say very much to each other on the ride home.

Once Jones was dropped off at her home by Miller, she texted Miller "Not a word of this is to be said to anybody." Miller replied, "Not a word of what?" Jones replied, "Exactly."

I asked Jones why she felt Miller would tell somebody about this incident. Jones told me that she did not know. Jones also told me that the texts were deleted. Jones told me that she was not going to say anything about this incident to anybody. Jones stated that her fiancé could tell she

was down and not acting her usual self on May 11, 2019 and she finally caved in and told him what had happened between her and Miller. Jones stated that her fiancé said that she better tell somebody about what happened or he was going to tell somebody about what happened.

Jones stated that this is when she called police.

Jones stated that Miller has never sexually assaulted her in the past. Jones stated that she wanted to prosecute in this matter.

INJURIES:

There were no visible injuries.

CRIME LAB:

N/A

CSC EXAM:

I transported Jones to the YWCA for a CSC exam.

EVIDENCE:

I retrieved a CSC kit as well as a toxicology kit from Mary Willah, the nurse that the YWCA. This CSC kit and toxicology kit were packaged per BLPD policy and procedure and CSC kit was placed into the refrigerator door in the evidence room and the toxicology kit was placed in cubby #1 inside of the refrigerator inside of the evidence room. The key to cubby #1 was placed into evidence locker #5 along with lab analysis forms.

The clothing that Jones originally gave me, the bikini top, bottom, and plaid shorts were photographed using a booking room camera and they were hung in drying locker #8.

ATTEMPT TO LOCATE SUSPECT:

SOS shows Miller staying at 131 Michigan Ave. in Marquette. Jones told me that she did not have a telephone for Miller for me to contact him. I asked Jones how she was texting him. Jones explained to me that Miller has a text only number, which he uses on his laptop. Jones then contacted her grandmother in an attempt to get Miller's phone number. Jones told me that her grandmother would not give her Miller's phone number. I was unable to located or make any sort of contact with Miller.

INTERVIEW WITH SUSPECT:

I was unable to located Miller for an interview.

ARREST:

No arrest was made.

WEAPONS:

No weapons were used.

CRIME VICTIM'S RIGHTS:

I provided Jones with her victim's rights as well as a case number for this incident.

PROSECUTION:

Prosecution is desired in this matter.

FIA:

No children were involved.

INTERVIEW WITH INVOLVED OTHER: (Aaron Smith)

On May 12, 2019, I made contact with Aaron Smith, an employee at the Hot Tub House. Smith told me that on May 10, 2019, he remembered Jones and Miller, because once they left, he went to clean the hot tub area and located two condom wrappers floating in the hot tub as well as three alcohol shot bottles in the trash can, which made him upset and this prompted him to make a note next to their names for future reference.

Smith did not have anything further to add reference this incident.

DVR:

Supplement Notes

INFORMATION:

I received this case for Follow Up. On 5/15/2019 I contacted the victim Melissa Jones who stated that she did wish to pursue prosecution. She agreed to come in Tuesday 5/21/2019 at 2:30pm for an interview as she planned to be in town that day for other business. On that date Jones was 45 minutes late and due to my schedule, I was unable to interview her at that time. She said she did not have reliable transportation so it was decided that I would interview her the following morning at her home in Marquette.

INTERVIEW VICTIM (MELISSA JONES):

On 5/22/2019 at approx. 10:45am I interviewed Melissa Jones at her home in Marquette. The interview was audio recorded using my handheld recorder and will be saved. During the interview, Jones' grandmother (Bertha Miller), who is also the suspect's mother, arrived and was highly agitated that Jones was making this report to the police. There was a confrontation between the two however Miller left without further incident when I asked her to. Below is a summary of the interview:

I first asked Jones what the blood relationship was between herself and Thomas Miller. She said that he is her maternal uncle. Her biological mother (Cheryl Jones) is his biological half sister as Jones and Miller share a mother in common (Bertha Miller). Jones said that Miller has known her since she was a baby and has been involved regularly in her and her family's lives without

interruption. They lived only about 15 minutes from her house. She said at one point, Miller, his wife, and his mother (Miller) even had temporary custody of her son for a year while she was pregnant after her divorce and trying to get back on her feet. I asked her about her relationship with him prior to this incident and she said "it was pretty open" and that she felt like she could talk to him about anything. She said she "trusted him 100%."

I then had Jones recount what happened regarding this incident with as much detail as she could. She said it happened on a Thursday and she reported it the next day on a Friday. She said she had been at one of her grandmother's house painting (which is his current residence). He came home around 5pm and came down to the basement where she was painting and they had just a normal conversation. He said he was going to go get a beer and she gave him her card and asked him to pick her up something as well. She said she normally does not drink much but she was having trouble with her fiancé and having troubles so she just wanted to relax. He came back with a 22 ounce of Smirnoff Watermelon Mimosa (vodka) and she drank it all. He asked her if she wanted to come back later for more drinks and barbecue and she said sure. He told her to go ahead and go home with her kids and get cleaned up and come back later which she said sounded good. Right before she left he asked her what did she think about going to the Hot Tub House because his back was hurting him. She said that sounded great because she was getting ready to have back surgery herself so she agreed. He said he would call and make the reservations.

Jones said she took her kids home and showered and came back to the house. She said she was feeling tipsy at that time. (She said she was also on medications that she wasn't sure how they would react with alcohol) so he drove to the Hot Tub House. They stopped first at a party store on Michigan Avenue and he got 4 alcohol "shooters" (shots). *****At this point in my interview, Jones' grandmother (Miller's mother) Bertha Miller knocked on the door and Jones answered it. I let the audio continue to record. Jones went to the door and told Miller that she was with a detective right now and the detective was recording her. Jones started to tell Miller she would have to talk to her later and Miller said "Well record me with it." Miller then stepped into the front door and looked at me, then looked at Jones. I introduced myself. Miller was visibly upset. She asked for my name again. Jones again told her that "we were recording for the prosecuting attorney" and Miller asked her "Why? Why did you even do this? As much as Thomas and I have backed you forever." Jones told her that she couldn't help the decision that her son (Miller) made. Miller looked at me and told me that Jones was a bully and that she would "beat the hell out of anybody." Jones calmly told Miller that she was not welcome right now. Miller demanded to know what was going on and was becoming more agitated. I explained to Miller that right now I needed to interview Jones because she was making an allegation. Jones again tried to speak calmly to Miller but Miller asked her why would she do this to them and Jones told her she wasn't doing anything; that Miller was the one who did this. Jones became upset at this point and she and Miller argued. Miller asked her how many people raped her and accused her of turning in her brother. Jones denied that allegation and became highly agitated herself and demanded that Miller leave. I gave Miller my card and told her she could speak to me later and asked her to leave at this time so I could continue my interview. Miller gave me her name and number and left without incident. I then continued my interview with Jones.

Jones said that they arrived late at Hot Tub House and their appointment was rescheduled for 7:30pm. She said the reservation was in her maiden name. Miller said he didn't have a way to pay for the reservation and she used her card and he gave her \$20 cash. They then went to an outdoor hot tub room. She already had her bathing suit on because she had it on under her clothes. He commented that he didn't have a bathing suit and was going in his underwear. She said he was wearing blue briefs. They drank some of the alcohol shots while they were in the hot tub just having "normal conversations." She said they talked about being divorced and they talked about different websites where they can find porn. She told him about how after her divorce how she had gone on adult dating websites and posted a picture of her breasts. He commented that now he was curious and wanted to see her breasts. She said she thought that was a little odd but she was comfortable with her body so she pulled her bathing suit top up and showed him her breasts. He had been on the other side of the hot tub and he then came over and put his hands on her and she pulled her top back down. She then grabbed two of the alcohol shots and drank one and gave him the other one to try to get him away from her and get his mind on something else. She said they then went back to "general conversation" and she relaxed. He had her move around the hot tub and try the different jets and she did. At that time they were sitting on the same side of the hot tub but facing different directions. Jones then recalled that before any of this happened; when they first got into the hot tub, he had taken his underwear off and said "You don't mind do you?" She said he was still underwater so she thought it was okay. She said "she didn't really think anything of it because he was her uncle and still under the water."

Jones then picked up where she had left off earlier saying he then started talking about his penis and how she would never see another penis that looked like his and he stood up and showed her his penis. She said it was semi-erect and she became very uncomfortable at that time. She explained that he has a ³/₄ circumcision so he has a flap of skin underneath his penis. He was pulling on it and telling her to look at the veins on it; that it has "extra sensitive feeling" and how it feels really good when people "do this and that." He then sat back down. I confirmed with her that the penis exposure occurred after she had showed him her breasts. She then explained that she is a medical assistant and is comfortable with her body and with other people's bodies so she hadn't really thought much about it (showing him her breasts). However she said she was "a little uncomfortable" with him showing her his penis. He then sat back down in the hot tub and they were having a normal conversation about non sexual things. She said she doesn't remember all of the things they talked about. She said she was pretty intoxicated at this time.

She recalled him coming closer to her and kind of "floating" in front of her while they were talking. He then moved closer to her and tried kissing her. She said she turned her head away from him. She said "I didn't want to kiss him. I didn't want him near me." She said he kept trying to kiss her. He then pulled her toward him with his hands grabbing her waist and he started "rubbing himself on me." She said he was fully erect at that time. At this point in the

interview, Jones began crying. She said she kept turning away from his kisses and he started putting his mouth on her chest. Jones cried harder in the interview and said "I didn't tell him to stop and I know that was wrong, I should've told him to stop but I had so many things going through my head. I was drunk. I was in a place I didn't know, I had no way to get home, you know, so I just turned my head away from him and didn't say a word, I didn't touch him and he took my bottoms off, first he started putting his fingers down in my vaginal area, then he took my bottoms off, he put himself inside of me, in my vaginal area and then he kept trying to kiss me and I kept my head turned away from him." Jones started crying more in the interview and said that he put his hands around her throat "and he squeezed. It wasn't enough to where it completely cut my airway off but it was pretty tight." I asked her why she thinks he did that (choking) and she cried and said she didn't know. I asked if he said anything to her and she said yes, he said "Are you ever gonna fucking cum?" She said "I didn't say a word. I just kept looking away. I didn't want... I just wanted it to be over. I wanted it to be done." I confirmed with her that they had been facing toward each other at the time. She said when he let go she twisted away from him to her left and he grabbed her and "started going from behind me." She said "he finished" and put his hand on her back, put his briefs on and got out of the hot tub. There was a phone call to say their time was almost up. She said she went and rinsed off; didn't shower completely because she just wanted to go home. She shampooed her hair and put her shorts on. She doesn't really remember much conversation on the way home if there was any. She recalls they got lost in construction and she was driving and was drunk. She said they never discussed what happened.

When she got home she doesn't recall eating dinner (her son later told her she had). She said there are probably bits and pieces that happened at the hot tubs that she doesn't remember; but she told the officer and me everything that she does remember. When she got home she said she was very upset about it. She said that Miller was out on bond for CSC against his biological daughter, and no one in the family believes her; they all say she is a liar. Jones said she herself "didn't want to do this, didn't want to tell the police, didn't want her grandma to find out" so she send Miller a text message telling him not to mention a word of this to anyone ever. He responded "about what" and she responded "exactly." She said she has been avoiding her grandmother for the past two weeks because she knows this is going to hurt her and she knew she would react the way she did today.

I asked Jones who was the first person she told and she said her fiancé, the next day because he had not been there when she came home that night. I asked her what made her tell him and she said "Because he wanted to have sex with me, and the thought of sex right now repulses me. I don't want him to touch me. I don't want anybody to touch me." Her fiancé convinced her that she had to contact police and stand up for herself. He told her even if she can't do it for herself, she should do it for her cousin. Jones went on to tell me that she had tried so hard to believe that Miller was not guilty of the CSC against her cousin (his daughter). She said she had supported him in proclaiming his innocence. I asked Jones how her own mother feels about all of this and

she said she is estranged from her mother. She said that the family was estranged from her cousin (Miller's accuser) for a long time indicating they don't know her very well.

I asked Jones if Miller used a condom with her and she said no. She said she was certain that he did not use a condom. She said she never saw any condom or wrappers anywhere. I told her what the manager had said about seeing condoms and she said she never saw any. I asked how she could be certain he never wore one and she said she guesses she couldn't be certain but reiterated that she never saw any. I asked her to put herself outside of the situation looking down and ask would Miller have known that she didn't want him to do those things to her (since she never said no or stop). Jones said "I would sure the hell hope so. One, he's my uncle, that's disgusting. Two, if somebody's not looking at you and not physically interacting with their situation you would think that they wouldn't want it." She went on to say if she were in bed with her husband and trying to fondle him and he's just rolling over and not saying anything "I'm gonna get the point that he's not interested and I'm gonna just go to bed." She reiterated that she didn't look him in the face, she didn't kiss him back and she turned away from him.

Jones said that she was molested by a cousin from the age of 6-10 and she disclosed at age 13 to her counselor but one in the family believed her and it was never reported to the police. She said no when asked if this has happened to her with anyone else. When asked about her ability to testify in court about this incident she said it will be difficult but she will do it.

INTERVIEW SUSPECT (THOMAS MILLER):

On 5/23/2019 I attempted phone contact with Thomas Miller using two possible phone numbers for him. Neither phone numbers appeared to be working. I then called his mother, Bertha Miller, and asked for a phone number to contact Miller. She declined to give me his number but said she would call him and have him call me back. She also mentioned that he is living in Marquette. A short time later I was contacted by Keeley Blanchard who identified herself as Miller's lawyer. She asked what the new allegation was and I advised her that Jones was accusing Miller of sexually assaulting her at the Hot Tub House on 5/10/2019, which included penile vaginal penetration. I asked if Miller was willing to give me a statement and she said no.

INTERVIEW AARON SMITH:

On 5/23/2019 I spoke to Aaron Smith, the employee at Hot Tub House who had given a statement to PSO Petersen. I had Smith clarify some information about the condoms he saw. He advised me that he never saw actual condoms; just two empty wrappers floating in the hot tub. He explained that the room has a private bathroom and more than one garbage can which had, of course, already been emptied. He said he also saw three small alcohol bottles, like the shot size

ones, in their bathroom trash can. He further stated that while the reservation was listed under Melissa Ringer, she appeared to sign in under a hyphenated last name (Jones-Ringer). The male also signed in but was not required to be on the registration. (The male's signature is illegible but appears to start with a T and the last name with a M). There is a third signature shown on their sign in log but Smith explained to me that was a mistake, that the person came in late and signed in under the wrong registration. Smith checked the name Thomas Miller and did not show him registering in the past few months. He said the current software has issues and he was unable to look back further than a few months prior but if Miller had registered prior to that, his name at least, should have been transferred over from the old software. I picked up a copy of the registration and sign in from Smith as well as the notation in the computer regarding the condoms and alcohol bottles. I noted that the phone number given when the registration was made was the same as one I had listed to contact Miller. While there I noticed cameras. Smith allowed me to view the footage from the date in question which showed Jones and Miller coming and going from the front desk to the room. The computer to download the video was being serviced but Smith said he would download the video onto a DVD as soon as the computer was back, which he expected within the week. He said the video would save on the hard drive for 28 days.

INTEVIEW OTHER (JOSEPH WILLIAMS)

On 5/23/2019 I spoke to Joseph Williams, Jones' fiancé, over the phone. The interview was audio recorded and will be saved. I asked him to tell me about Jones' disclosure to him. Williams advised me that he had not been home on 5/10/2019 but Jones told him immediately when he came home on 5/11/2019. He said that they left the house because Musser didn't want to tell him in front of the kids so they drove to a park and sat in the car in the parking lot. Jones started by telling Williams that her cousin (Miller's daughter) wasn't lying about the accusations she had made against him. Williams asked her what she meant and Jones was very distraught and crying. She told him how she had been painting at her grandma's house and Miller came home and invited her back for burgers. They then went to the Hot Tub House and he asked her to use her card and gave her cash and he paid for alcohol that they both drank. Williams said that Jones did not go into much detail about what happened because she was not comfortable telling him the details but she said "He raped me." She also told him that Miller kept asking her "Why won't you cum?" and that Miller had choked her. Williams said that Jones had a feeling of guilt "for whatever reason victims feel guilt" but she kept saying she was sorry and crying and was distraught. Williams said he calmed her down and told her it wasn't her fault and that Jones had really wanted to believe Miller was innocent of the charges regarding his daughter and that she had entirely trusted him and he had violated that trust.

When asked what he thinks prompted her to tell he said he assumes that she needed to tell someone she trusted. She expressed reluctance to "destroy the family" further specifically her

grandma. Williams encouraged Jones to report this and she did. Williams also thought that Miller had made contact via a couple texts through his ipad account to Jones. I later confirmed with Jones that it was Miller contacting her in response to her trying to get Miller's phone number from her grandma for PSO Petersen.
